Cooper for the work he is undertaking and putting forward the village hall as a centre with its easy access, parking and being on a bus route.

Cllr. Allison informed Noeline Turner, a parishioner has celebrated her 105th birthday and offered congratulations to her and her family.

Cllr. Allison also informed Neighbourhood Watch is looking for a local co-ordinator.
